## NOTICE TO OWNER/OPERATOR

THE ARIZONA STATE MINE INSPECTOR WILL DETERMINE WHETHER TO EXTEND THE TIME TO BEGIN RECLAMATION BASED UPON THE FACTORS OUTLINED IN A.R.S. § 27-1226. PLEASE NOTE THAT YOU WILL BE REQUIRED TO MAINTAIN YOUR RECLAMATION FINANCIAL ASSURANCE, REPORT YEARLY ON THE STATUS OF THE MINE, AND KEEP THE MINING PROPERTY IN A SAFE AND SECURED CONDITION PURSUANT TO A.R.S. § 27-318. EXTENSIONS MAY ONLY BE GRANTED FOR A PERIOD OF FIVE YEARS. THIS FORM MUST BE SUBMITTED TO THE RECLAMATION DIVISION OF THE ARIZONA STATE MINE INSPECTOR'S OFFICE, 1700 WEST WASHINGTON STREET, SUITE 403, PHOENIX, ARIZONA 85007, AT LEAST 45 DAYS BEFORE RECLAMATION IS REQUIRED TO BEGIN.
